1. Team Application

The team _____ applies herewith for the participation in the ELROB event. The participation fee will become due and payable immediately on confirmation of participation.

2. Team Representative

I, _____ as team leader representing team _____ certify that I am authorised by the company _____ and the team members (1) to represent the team in all matters concerning the ELROB event and (2) to submit all necessary statements. The company is prepared to assume responsibility for any and all activities of the team that may take place during the ELROB event in its entirety.

3. Liability

Explicitly, each participant/team shall be solely liable for any loss, damage or injury to third parties resulting from the performance of its participation in the ELROB event. Each participant/team shall be liable to each of the other participants/teams pertaining acts or omissions of itself and of its employees, agents and subcontractors indispensably provided that such liability shall not extend to claims for indirect or consequential loss or damages such as, but not limited to, loss of profit, revenue, or the like. This shall not apply in the case of damage caused by a wilful act or gross negligence. Additionally, each participant/team agrees to indemnify and hold harmless the organizers of the ELROB event (i.e. FKIE, its employees and contractors and their employees acting on behalf of FKIE in connection with the ELROB event) for any loss, damage or injury to third parties or other teams or other parties resulting from the performance of the said participant/team participation in the ELROB event. The liability of the organizers of the ELROB event is limited to cases of damage caused by wilful act or gross negligence and to any statutorily mandatory liability.

4. Insurance

For any damage resulting from his own or his agents' responsibility, the team leader/company undertakes to take out and maintain, at his own expense, adequate liability insurance cover with a limit of at least € 5.000.000 for any one event for personal injuries and damage to property as well as in respect of public and products liability.

5. Applicable Law and Jurisdiction

The legal domicile for all disputes arising from or in connection with the team's participation in the ELROB is Munich, insofar as the team/company or team member does not have a place of general jurisdiction in Germany. This application and all disputes arising from or in connection with the participation in the ELROB event shall be governed in accordance with the laws of the Federal Republic of Germany.

6. Severability clause

Should any provision of this form be or become ineffective or impracticable after contract conclusion, this shall not affect the validity of the remaining provisions of this form. The parties commit themselves to replacing any such ineffective or impracticable provision part by an effective or practicable one which comes closest to the intent and purpose of the replaced one. The preceding provisions apply accordingly in case that the contract proves to be incomplete.

7. Acceptation of Rules

By signing the application, the participant/team recognizes and fully accepts the terms of participation.

8. Photograph, Video and Documentation Release

I hereby grant permission to the rights of my image, likeness and sound of my voice as recorded on audio or video and the provided documentation (e.g. Team Information etc.) without payment or any other consideration to ELROB organisation.
