## **Data protection**

### **Description of the data processing and legal basis**

With this form, we offer the opportunity to register for ELROB 2020. The personal data, which you enter into this PDF form and send to us via e-mail, will be stored by the BAAINBw for the purpose of conducting the ELROB. Your data will not be passed on to third parties outside the Bundeswehr.

By actively submitting the PDF form, you give consent to the processing of your personal data by the BAAINBw.

We process personal data in accordance with the provisions of the EU General Data Protection Regulation (GDPR) and the German Data Protection Act (BDSG).

### **Purpose of the data processing**

We process personal data for specific purposes pursuant to Art. 6(1), Subparagraph 1(a) GDPR. In particular this includes:

- planning the infrastructural equipment on site (catering, sanitary facilities, medical supply capacity),
- military security,
- notification of the guests and participants about important ELROB-related topics, like changes in the schedule or location, and other relevant information.

We might contact you at the specified email address

- up to 1 week before the event once a week,
- daily during the event and
- once a week after the event

The right of contacting you expires when the data is deleted (see duration of storage).

### **Duration of storage**

The data will be deleted as soon as it is no longer required to achieve the purpose for which it was collected, but no later than the end of December 31, 2020.

As a user, you have the option at any time to cancel the registration and have the stored data deleted. You can have your personal data changed at any time. Please contact us again at [elrob2020@bundeswehr.org](mailto:elrob2020@bundeswehr.org). We will then confirm the deletion of your data within 10 days of receiving the request for deletion.

## **Liability**

Explicitly, each attendee/participant/team shall be solely liable for any loss, damage or injury to third parties resulting from the attendance in the event. Each attendee/participant/team shall be liable to each of the other attendees/participants/teams pertaining acts or omissions of itself and of its employees, agents and subcontractors indispensably provided that such liability shall not extend to claims for indirect or consequential loss or damages such as, but not limited to, loss of profit, revenue, or the like. This shall not apply in the case of damage caused by a wilful act or gross negligence. Additionally, each attendee/participant/team agrees to indemnify and hold harmless the organizers of the event (i.e. Bundeswehr, FKIE, its employees and contractors and their employees acting on behalf of the Bundeswehr or FKIE in connection with the event) for any loss, damage or injury to third parties or other teams or other parties resulting from the attendance of the said attendee/participant/team participation in the event. The liability of the organizers of the event is limited to cases of damage caused by wilful act or gross negligence and to any statutorily mandatory liability.

## **Applicable Law and Jurisdiction**
